POWER OF ACCESS TO PUBLIC INFORMATION

CANCÚN, QUINTANA ROO February 20 - 23, 2005



Transparency and the right of access to public information have grown to be fundamental themes for democratic advancement. As civil society matures, as the interconnectivity between nations deepens and democracies consolidate, the issues of access and transparency are compelling in public, national and global agendas.

Typically, democracy supposes that society has resolved the problem of how to access power, with clear and just rules, yet its advance results in a theme of importance: how to practice and control democratic power. In the core of this new agenda lay transparency and access to information.

This is why there is a true international movement of more than 50 countries that have approved access to information laws and 30 more, that are going through a process of approval of a law that regulates such matter.

This reality deserves a discussion, and an international space in which such process is held and promotes the inclusion of this issues, in the agendas of multilateral organizations (such as IMF, WB, OECD, IDB, amongst others) as well as the sub national governments of the world.

This is the reason why we have summoned the **Third International Conference of Information Commissioners** as a meeting space for authorities and actors of the civil society whose mission is the protection and promotion of this right. This is a Conference held annually since 2003, which will be organized by Mexico, in Cancún, Quintana Roo, through the Federal Institute of Access to Public Information (IFAI).

More than 50 countries have been invited to this event, amongst them 11 countries in the world that have analogue institutes to IFAI (Belgium, Canada, Slovenia, Estonia, France, Hungary, Ireland, Latvia, Portugal, United Kingdom and Thailand). Also participating are, nations that do have regulated this matter, as well as countries that are promoting and working inside the government and through society for its approval. We have also called upon actors from diverse organizations that hold a comparative and global view of the advances and challenges of access to information.

The III ICIC will be a place to deliberate and debate, to cross and exchange experiences amongst commissioners and governmental authorities of access to information and personal data, organizations of civil society that represent a relevant role in the impact of this issue, actors from multilateral institutions and international organizations that are interested in the issue.

This Conference has a central objective: recognize and diffuse the capacity and power that access to information has to change everyday life, public deliberation and government exercise. We will explore the experiences that due to their relevance and meaning are able to modify inertias, change behavior and better the relation between government and citizens. Also, we will make a national and international call to ratify the commitment of contemporary democracies and multilateral organizations with information openness.

The organization of this Conference in Mexico constitutes a unique and unrepeatable opportunity. This Conference will call upon the protagonists, authors and promoters that characterize the right of access to information; actors whose public trajectory and relevance are of national and international relevance, or that occupy a strategic role in global institutions, they will help us relauch this call in favor of transparency and freedom of information in the world.
